## **Details of innovations and other initiatives for creation and transfer of knowledge**

The institute has well established departments and labs for clinical research and training. Innovative practices and initiatives of the last five years are outlined below.

### **1. Innovative practices**

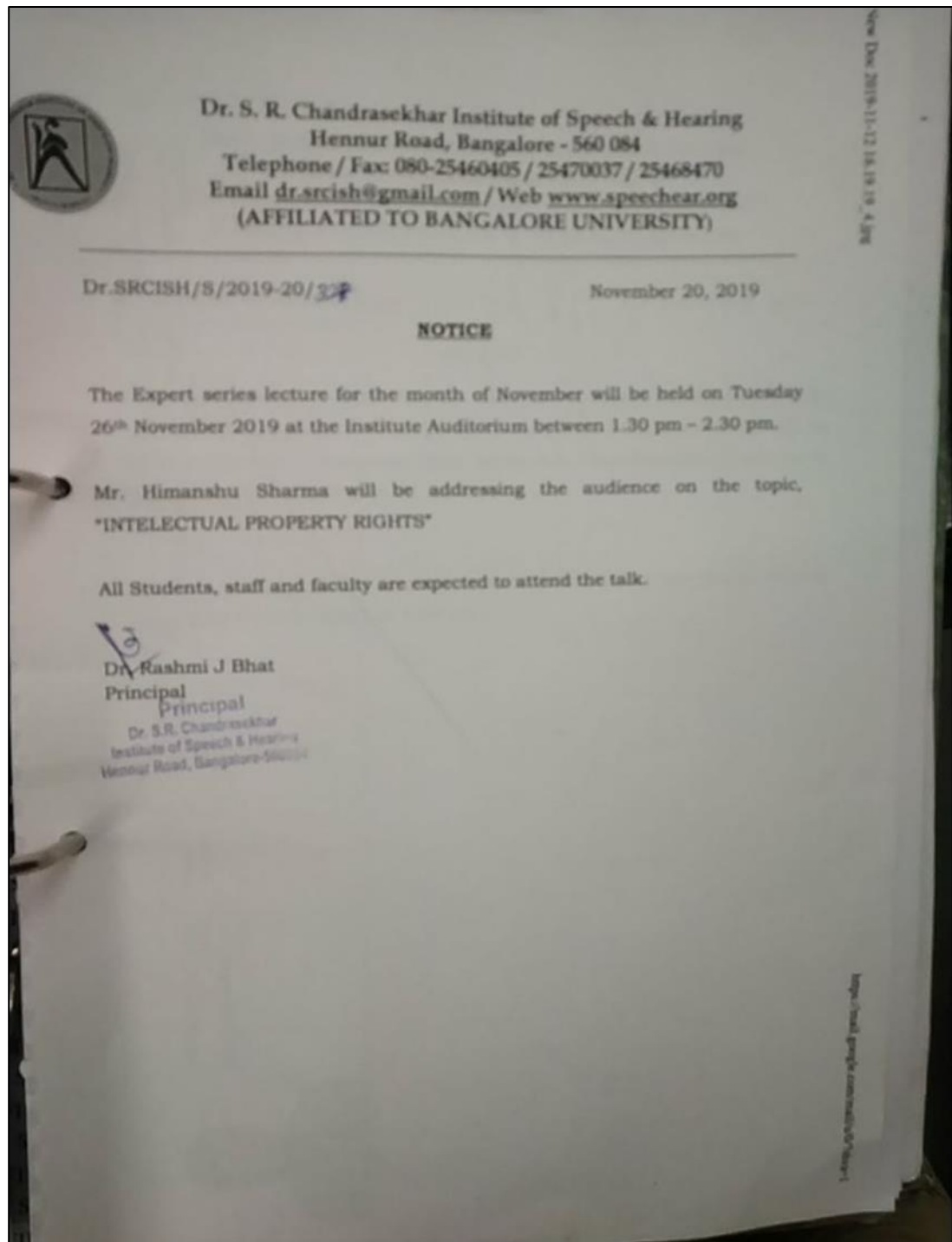
A sound measurement mannequin named Karna (which means ear) was created by DR. SRC ISH based on the Jolene's hazardous decibels. Karna evaluates the sound output of portable audio players to let users realise the negative impacts of listening to loud music or other noises all the time. Six mannequins have been created as a part of this financed project. One has been placed at Mount Carmel permanently for regular measurements by students. In this regard, we get updates. The institute uses the mannequin to raise awareness of noise-induced hearing loss and recreational hearing loss in various settings. The mannequin was unveiled, and public awareness was raised, in keeping with the 2022 World Hearing Day theme, "To hear for life, listen with care." Because they were a targeted audience that utilise more personal listening devices, college students were given special attention for boosting awareness. The dangers of continuous use of loud Personal Listening Devices were stressed by the researchers when they talked at institutes on noise. As a result, students started to pay attention and were able to recognise and implement the skills they had learned.



## 2. Intellectual property rights

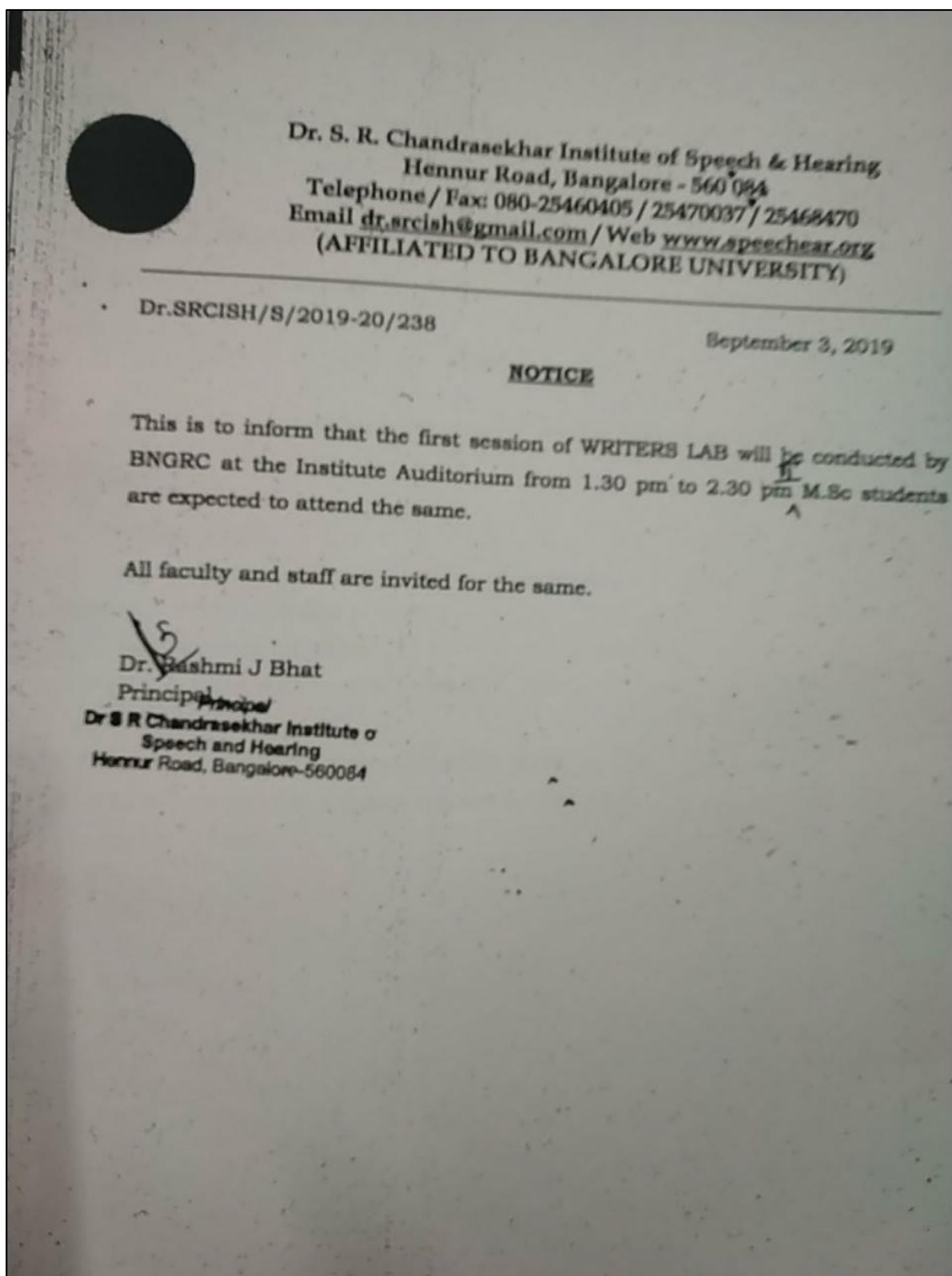
